

**Promotion Rules (“Rules”) – MetroFibre Direct Customer SpeedUp Promotion:  
Isipingo Rail, Isipingo Hills, Isipingo Beach, Orient Hills & Lotus Park (“Promotion”)  
 (“Promotion”)**

## **Introduction**

1. This promotion (“Promotion”) is being run by MetroFibre Networx Proprietary Limited (company registration number 2007/024366/07) (“MetroFibre”).
2. This offer may not be used in conjunction with any other MetroFibre promotional offer.
3. This Promotion is only available to new and existing customers that use any accredited FTTH Reseller on the MetroFibre FTTH Network (“**Customers**”) that reside in an area listed below (“**Promotional Areas**”) with existing and deliverable MetroFibre FTTH Network already in place.

4. The Promotion began on 15 August 2024 and will be extended from 31 January 2025 to 31 March 2025 (“**Promotion Period**”)

## **The Promotion**

5. Subject to the eligibility criteria below, the Promotion offers new and existing MetroFibre Reseller Customers that sign up/ upgrade during the Promotional Period in the Promotional Area, the following:
  - 5.1. Installation of a fibre infrastructure Termination Point at an on-network residence at no cost to the unit owner/ occupant subject to the placing of an order for a fibre data service simultaneously with the order for installation, via an approved MetroFibre Reseller.
    - 5.1.1. Termination Point – small distribution box which is then connected to the Optical Network Terminal (“ONT”):
  - 5.2. no service activation fee or installation fee will be charged subject to MetroFibre standard policies; and
  - 5.3. additional line speed on top of their selected package’s standard speed (“**Promotional Speed**”) at no additional cost (see table below) for 12 (twelve) months/invoices from date of activation/upgrade as per the below packages and applicable speeds. Thereafter standard bandwidth speeds apply to the package

6. Standard Monthly subscriptions rates are priced/charged are per MetroFibre's standard terms and conditions ("**Standard Terms and Conditions**") and thus \*subject to any standard price adjustments.

6.1. For avoidance of doubt, this means that during the 12 months of experiencing the Promotional Speed, the Monthly Subscription rates are not fixed as quoted in the above table but subject to standard pricing increments and adjustments.

7. For avoidance of doubt, the following is an illustration of how the SpeedUp Promotion will work:

7.1. For new Customers placing a deliverable service order with an approved MetroFibre Reseller within the Promotion Period:

7.1.1. Scenario 1: The Customer signs up for a SpeedUp 25Mbps (25 Mbps line speed) at point of sale is activated and invoiced for this package. Customer experiences 75Mbps line speed for 12 months from date of activation.

7.1.2. After 12 months the Customer's line speed will automatically revert to 25Mbps line speed unless the customer requests a standard package upgrade.

7.2. For existing Customers placing an upgrade on their current active service order with an approved MetroFibre Reseller within the Promotion Period

7.2.1. Scenario 2: The Customer is currently on a standard 25Mbps package and places an upgrade request for the SpeedUp 75Mbps. Customer will experience a 250Mbps line speed from the effective upgrade date and will be invoiced at the standard monthly subscription rate for 75Mbps package.

7.2.2. After 12 months the Customer's line speed will automatically revert to 75Mbps line speed

unless the customer requests an additional standard package upgrade.

8. Should a customer move to a new address outside of the Promotional Areas list above within 12 months of accepting the Promotion they will no longer be eligible for the promotional SpeedUp package and its additional speed and will also be liable for the activation and installation charges if applicable at their new address as per MetroFibre's Standard Terms and Conditions.
9. Standard Installation includes up to 20 running meters of cable infrastructure per the standard terms and conditions.
10. Prices quoted for non-recurring costs and charges (including applicable access build, installation, and activation costs), equipment and monthly recurring costs are exclusive of VAT.
11. All business packages are excluded.
12. Should the Promotion, for any reason whatsoever, become unavailable, MetroFibre may in its sole discretion award a non-promotional benefit of similar value to eligible participants.

### **How to Participate**

! To participate, Reseller's must place a service order or upgrade request on the Reseller portal during the Promotion Period.

### **Eligibility**

14. Customers must reside in an area listed below with the existing and deliverable MetroFibre fibre optic network service already in place.
  - 14.1. Isipingo Rail
  - 14.2. Isipingo Hills
  - 14.3. Isipingo Beach
  - 14.4. Orient Hill
  - 14.5. Lotus Park
15. Existing customers are eligible for this promotion if their current monthly recurring fee is lower than the standard monthly subscription rate they are upgrading too.
  - 15.1. For avoidance of doubt a Customer currently active on a standard 25Mbps package cannot upgrade to the SpeedUp 25Mbps. A Customer on a standard 25Mbps can only benefit from this promotion if they upgrade to a SpeedUp 75Mbps or higher SpeedUp promotional package.
16. Only one promotion can be claimed per unit/dwelling and no other specials can be claimed concurrently.
17. Should the customer cancel their order prior to activation within 30 (thirty) days from the installation of a fibre infrastructure Termination Point and ONT in terms of this promotion, MetroFibre shall be entitled to demand full payment of the installation and activation costs of the CPE from the person placing the order.

18. By placing an order in terms of this promotion you confirm that you accept the provisions of these Rules.

### **General**

19. These Rules may be amended by notification at any time during the Promotion.
20. The Promotion is exclusively for eligible participants and is not transferable, not exchangeable and cannot be exchanged for its cash value.
21. Participants hereby indemnify MetroFibre and its agents, against any / all claims for any injury, loss or damages, whether direct, indirect, consequential or otherwise, arising from any cause whatsoever from their participation in any way howsoever in this Promotion.
