

Promotion Rules ("Rules") – Black Friday Wholesale Special

Introduction

1. This promotion ("**Promotion**") is being run by Metro Fibre Networkx Proprietary Limited, company registration number 2007/024366/07 ("**MetroFibre**").
2. This offer may not be used in conjunction with any other MetroFibre promotional offer.
3. The Promotion begins on 18 November 2022 and ends on 26 November 2022 ("**Promotion Period**").

The Promotion

4. This Promotion is applicable to the business wholesale packages below:
 - i. 200 Mbps for 24 months at R3199.00pm
 - ii. 500 Mbps for 24 months at R5199.00pm
 - iii. 1 Gbps for 24 months at R6399.00pm
 - iv. 2 Gbps for 24 months at R7999.00pmthe "**Promotion Packages**".
5. The Promotion is available to new and existing end-users/customers of MetroFibre accredited wholesalers, who place an order with the wholesaler during the Promotion Period for any one of the Promotion Packages, which wholesaler will then subsequently place an order with MetroFibre within 7 (seven) days.
6. The benefits of the Promotional Packages are increased internet speeds for discounted monthly subscription charges.
7. The Promotion only applies to monthly subscription charges and does not include activation and access build costs.
8. Activation / connection fees cost R3000.00 for on-net and off-net customers. Access build costs will be quoted to end users separately. If existing devices onsite cannot accommodate the capacity ordered, MetroFibre may arrange for the installation of suitable equipment which may be quoted and charged to the customer's account additionally.
9. The following applies to the coverage of the Promotional Packages on offer:
 - i. 500Mbps, 1 Gbps and 2 Gbps can be claimed nationally (On-net and Off-net) subject to feasibility and network availability;
 - ii. 200 Mbps can only be claimed on the MetroFibre network (On-net).

10. All customers will qualify for the Promotion Packages provided they comply with the eligibility and other requirements set out in these Rules.
 11. Should the Promotion, for any reason whatsoever, become unavailable, MetroFibre may in its sole discretion award a similar promotion of similar value to eligible customers.

16. Fibre to the home ("**FTTH**") packages are excluded from the Promotion.
17. The Promotion is open to all new and existing end-users and customers of accredited wholesalers wishing to secure a Promotional Package.
18. The Promotional Packages will be activated to the end-user/customer within MetroFibre's relevant product specifications, subject to all relevant information being provided to MetroFibre and being confirmed by MetroFibre.
19. New and existing customers will be notified by email once the new service or upgraded service is activated.
