

Promotion Rules ("Rules") – MetroFibre MetroConnect Customer Zwide Promotion

1. Introduction

- 1.1. This promotion ("**Promotion**") is being run by MetroFibre Networx Proprietary Limited (registration number 2007/024366/07) ("**MetroFibre**").
- 1.2. This offer may not be used in conjunction with any other MetroFibre promotional offer.
- 1.3. This Promotion is available to new and existing customers that use MetroFibre as their Internet Service Provider (ISP) ("**Customers**"), that reside in an area listed below ("**Promotional Area**") with existing and deliverable MetroFibre FTTH Network already in place:
 - 1.3.1. Zwide (Eastern Cape Province).
- 1.4. This Promotion is valid from 01 April 2026 to 31 May 2026 ("**Promotional Period**"). MetroFibre has implemented its annual standard price increase, effective 1 April 2026. This affects the standard (non-promotional) pricing applicable to the services offered under this Promotion.
- 1.5. Customers who purchase services during the Promotion Period will continue to benefit from the applicable promotional prices for the full duration of the Promotion. The promotional prices themselves have not been increased or amended.
- 1.6. Once the Promotion ends, the updated standard prices, as set out in the revised pricing table attached hereto, will apply to the relevant services.
- 1.7. The Promotion is not available or valid to customers utilising any other fibre network provider.

2. The Promotion

- 2.1. Subject to the eligibility criteria below, the Promotion offers new and existing MetroFibre MetroConnect Customers that sign up and/or top up during the Promotion Period in the Promotional Area, the following:
 - 2.1.1. Installation of a fibre infrastructure Termination Point at an on-network residence at no cost to the unit owner/occupant subject to purchasing a Starter Pack directly with MetroFibre.
 - 2.1.2. Termination Point – small distribution box which is then connected to the Optical Network Terminal (ONT);
 - 2.1.3. no service activation fee will be charged; and
 - 2.1.4. a discounted rate ("**Promotional Price**") on the below packages is available during the Promotion Period thereafter standard rates apply. The table below outlines the standard and discount pricing.

- 2.2. The standard package prices are priced/charged as per MetroFibre's standard terms and conditions ("**Standard Terms and Conditions**") and thus *subject to any standard price adjustments.
- 2.3. For avoidance of doubt, this means that the standard package prices are not fixed as quoted in the above table but subject to standard pricing adjustments.
- 2.4. Should a Customer relocate to a new address outside of the Promotional Area listed above during the Promotion Period, the Customer will no longer be eligible for the promotional package at the new address. The Standard Prices will automatically apply at the new address and the customer will be liable for the activation and installation charges if applicable at their new address as per MetroFibre's Standard Terms and Conditions.
- 2.5. Standard Installation includes up to 20 (twenty) running meters of cable infrastructure per the standard terms and conditions.
- 2.6. Prices quoted for non-recurring costs and charges (including applicable access building, installation, and activation costs), equipment and monthly recurring costs are inclusive of VAT.
- 2.7. All business packages are excluded.
- 2.8. Should the Promotion, for any reason whatsoever, become unavailable, MetroFibre may in its sole discretion award a non-promotional benefit of similar value to eligible participants.

3. How to Participate

- 3.1. To participate, customers must purchase a Starter Pack and/or Top-Up packages within the Promotion Period by:
 - 3.1.1. contacting the MetroFibre Sales Team telephonically or via WhatsApp on 087 151 4000 during standard business hours; or
 - 3.1.2. placing an order on the MetroConnect website at www.metroconnect.metrofibre.co.za; or
 - 3.1.3. completing a physical order form through direct marketing.

4. Eligibility

- 4.1. Customers must reside in an area listed below with the existing and deliverable MetroFibre fibre optic network service already in place:
 - 4.1.1. Zwide (Eastern Cape Province).
- 4.2. Both new and existing customers are eligible for this Promotion.

- 4.3. No other specials can be claimed concurrently with this Promotion.
- 4.4. By purchasing a Starter Pack and/or Top-Up Package in terms of this Promotion you confirm that you accept the provisions of these Rules.

5. **General**

- 5.1. These Rules may be amended by notification at any time during the Promotion.
- 5.2. The Promotion is exclusively for eligible participants and is not transferable, not exchangeable and cannot be exchanged for its cash value.
